> **Buildings**

Furniture, appliances, electronics, clothing and personal possessions.

> **Contents Outside the Home**

Items such as jewellery, watches, laptops and portable electronics (subject to limits and conditions).

> **Public & Personal Liability**

Protection if you are held legally responsible for injury to others or damage to their property.

Coverage Options

> **Full Coverage**

Loss or damage arising from both Catastrophe and Minor Perils, including hurricane, windstorm, earthquake, flood, theft, burst pipes, fire and accidental damage.

> **Non-Catastrophe Coverage**

Protection for Minor Perils only, such as theft, lightning, explosion, burst pipes, accidental damage and fire. Catastrophe events (e.g., hurricane, windstorm, earthquake and flood caused by these events) are excluded.
